**ANSWER TO NOTICE OF CLAIM/AFFIDAVIT OF DEBT**

My name is Jane Doe, and I am representing myself in this action. In response to each of the numbered paragraphs of the Plaintiff's Affidavit of Debt, "Exhibit A" I state as follows:

1. The allegations of Paragraph One are: Part one: Defendant denies the allegations contained in paragraph 1 of the Affidavit of Debt as Defendant is without information or knowledge sufficient to form an opinion as to the truth and accuracy of alleged assignments and entitlements.

I have been making monthly payments on-line to Deaconess since before this date of service which I will

bring to court with me, but I have also never received any correspondence about this debt as it to be a collection.

4. The allegations of Paragraph Four are: Defendant admits to the allegations in paragraph four.

6. The allegations of Paragraph Six are: Defendant denies the allegations in paragraph six. Plaintiff failed to send any correspondence before bringing on a suit. Defendant has been making regular monthly payments to (Name of facility) on-line "Exhibit B", and although when looking at the payment history it shows different account numbers, my account on-line comes up only under my name and I consistently make payments. I have not received from (name of facility) via mail or phone such indications that I was being sent to collections, or a suit was being filed for me to rectify this account number if that were the case.
